**Terms and Conditions – 2020 Incitec Pivot Fertilisers Winter Crop Planting Promotion  
(NSW permit number: LTPS/20/42590)**

1. The promoter is Incitec Fertilisers Pty Ltd (IPF) (ABN 42 004 080 264) of Level 8, 28 Freshwater Place, Southbank, VIC 3006 (“Promoter”). Telephone +61 3 8695 4400.
2. The promotion is the 2020 Incitec Pivot Fertilisers Winter Crop Planting Promotion (“Promotion”).
3. Information on how to enter and prizes forms part of the terms of entry. Entry into the Promotion is deemed acceptance of these Terms and Conditions.
4. If there is any inconsistency between these Terms and Conditions and anything else that refers to this Promotion, these Terms and Conditions will prevail.

**Who can enter**

5. #### **How to enter**

11. Entrants must receive delivery of one of the eligible IPF products during the Promotional Period and complete the [submission form](#) provided in the link and via [www.IPFbeattherush.com.au](http://www.IPFbeattherush.com.au); and provide proof of delivery docket. This information, including relevant IPF dealer, business name and contact details, will be used to determine proof of purchase via the designated IPF dealer where product was purchased by the entrant to the promotion.
12. The Promoter reserves the right, in its sole discretion, to investigate proof of purchase of eligible products. If an entry cannot be verified to the Promoter's satisfaction, the entry will be deemed invalid.
13. The eligible IPF products are:
